IMPORTANT INSTRUCTIONS FOR CANDIDATES ADMITTED ON ACPC-GoG SEATS IN B.PHARM.

It is informed to all candidates, who were allotted seats on ACPC-GoG seats during 1st and 2nd round of admission by ACPC and provisionally confirmed their intent of admission at this college by deposit of token fee of Rs. 20000/- OR given consent with ZERO fee (Freeship Card for SC/ST candidates) that:

1. They should report to college with the following documents at an earliest date to complete the admission formalities on working days between 9.00 am to 3.00 pm. (Diwali Break - 12th to 19th Nov 2020).
 - (a) Provisional Admission Letter downloaded from Candidate log-in of ACPC.
 - (b) Copy of Class XII marksheet
 - (c) Copy of GUJCET-2020 marksheet
 - (d) Copy of Class X marksheet
 - (e) Copy of School Leaving Certificate
 - (f) Copy of Aadhaar Card
 - (g) Copy of Caste certificate alongwith NCL and Income certificate (if applicable)
 - (h) First page copy of bank passbook showing details of bank account.
 - (i) Passport size photographs- 5 Nos.
 - (j) Original copy of Freeship card for SC/ST candidates, if token fee of Rs. 20000/- not paid online at ACPC bank account. If freeship card is not available with them then the candidate has to deposit semester fee at college.
 - (k) Deposit of remaining semester fee through cheque/ DD/ Online.
2. Bring original copy of above documents for its verification at the time of reporting.
3. It should be noted that if a candidate do not report at college with above documents within stipulated date as notified by ACPC, In that case the candidate may lose his right of admission at this college.
4. The students should report to college to complete the admission formalities as soon as possible.
5. A candidate may withdraw or cancel his admission during the admission process or before date as notified by ACPC as per norms. However, it should be noted that as per ACPC norms refund of token fee deposited will be applicable if such vacated seat is filled by waiting candidate and such admission made against vacated seat is duly approved by ACPC. For refund of token fee deposited at ACPC bank account in above cases will be processed by ACPC as per norms (Please refer ACPC website www.jacpcldce.ac.in for further details).
6. In case of queries if any, the candidates may contact college office during working days between 9.00 am to 3.00 pm. The college office will remain closed from 12th to 19th Nov 2020 for Diwali break.
