Admission Procedure in 50% ACPC-State Quota seats of B.Pharm.

50% of total B.Pharm intake is to be filled by the ACPC, Gujarat state. Please refer the website of Admission Committee www.jacpcldce.ac.in for number of seats along with category reservation to fill on ACPC-State Quota Seats. The candidate needs to apply to the ACPC at www.gujacpc.nic.in for centralised admission process to get admission in these seats. The eligible candidates would be allotted admission by ACPC as per the merit prepared considering the results of the qualifying exam (12th board exam) and GUJCET of the current year.

The candidates are advised to refer the website of Centralised State Admission Committee (ACPC): www.jacpcldce.ac.in and www.gujacpc.nic.in for the further details such as eligibility and the procedure of admission on ACPC-State Quota seats.

The candidates may take the help of admission counselors available at the designated **ACPC-Cyber Centre** located in college premises for filing online application form for ACPC-State quota seats and further guidance free of cost.

The candidates are advised to bring the following documents for filing online application for admission on ACPC-Quota seats:

- 1. Photograph in soft copy of 100kb size in jpg format
- 2. Class XII marksheet
- 3. GUJCET- 2021 hall ticket
- 4. School Leaving Certificate/ Transfer Certificate
- 5. Caste Certificate, Income certificate, Non-Creamy Later certificate for SEBC candidates (if applicable).

If the seats remains "Vacant OR Not reported" after completion of the admission process by the ACPC (i.e., after the final round of allotment), then admissions of such vacant seats would be processed directly by the Institute as per the norms of the ACPC.

The candidate may lose his right of admission against ACPC seat allotment, if he doesn't report to college within the stipulated date to complete the admission formalities at the college. The photocopies of all relevant documents alongwith ACPC allotment letter, token fee receipt and passport size photo has to be submitted at the time of reporting and will be verified with the

original copies. The remaining fee is to be deposited through NEFT/ IMPS/ RTGS/ Cheque/ Demand Draft at the college to confirm his/her admission.

A candidate may withdraw or cancel his admission during the admission process or before date as notified by ACPC as per norms. However, it should be noted that refund of fee deposited shall only be applicable if such vacated seat is filled by waiting candidate and such admission made against vacated seat is duly endorsed by ACPC. Refund of fee in such cases shall only be processed as per norms after completion of admission process and its endorsement by ACPC.
