Admission Procedure In Management Quota Seats of M.Pharm. (2021-22)

Candidates who are interested to take admission in Management Quota seats in M.Pharm course during session 2021-22 at ROFEL Shri G.M. Bilakhia College of Pharmacy should fill the "Application Form" available at college office.

N.B.: Few scholarships are available for candidates admitted in M.Pharm. To know about the details of the same, candidates are requested to contact in person at college office for the same.

The candidates are advised to refer the website of Centralized State Admission Committee (ACPC): www.jacpcldce.ac.in and www.gujacpc.nic.in for seats available and eligibility of admission on MQ seats.

Filing Application Form for Management Quota Seats:

Fill all the details asked in the Application Form. Attach all required documents alongwith application form as asked in the application form. Ensure that all entries are correct. It is informed that the college can reject application OR cancel admission, if any false information provided is detected even at a later stage. All documents pertaining to the eligibility of admission shall be verified with original.

Preparation of Inter-se-Merit:

The inter-se-merit will be prepared of all such applications received before due date on the basis of "ACPC Merit Rank" declared by ACPC and the seats will be offered on the basis of their preference mentioned in the form.

The candidates to whom admission is offered, has to deposit fees through NEFT/ IMPS/ RTGS/ Cheque/ DD by next day. If the fee is not deposited within stipulated time, then their right of admission will be forfeited and the seats will be offered to the next waiting candidates on interse-merit.

The waitlisted candidates on the MQ Inter-se-merit list will be considered for Vacant Seats against Cancellation OR ACPC-State Quota Seats OR due to not-reporting if any.

N.B.: It is hereby informed that candidates with 55% aggregate in B.Pharm, who did not have PGCET-2021 merit rank or have GPAT qualified scores can also apply in vacant seats if any. They must contact the college office for the same.

A candidate may withdraw/ cancel his admission during the admission process. However, it should be noted that refund of fee deposited shall only be applicable if such vacated seat is filled by waiting candidate on the inter-se-merit and such admission is duly approved by the ACPC. Refund of fee in such cases shall be processed after deduction of processing fee as per norms after completion of admission procedure in MQ seats and its approval by ACPC.
